#### Tuition Fees include the following

- IT Levy and Laptop Hire Levy
- Camps and Excursions Levy
- High School Levy for Yr 8 – Yr 10
- Student Accident Insurance
- Stationery, books, visiting performers and special events

#### Laptop Hire Levy - Marion Yr 7 - Yr 10

All students in Year 7 to Year 10 are allocated a laptop on a hire basis, the cost of which is included in the school fees. The laptop remains the property of the school and is to be returned when the student leaves. A separate line will appear on your statement to show the levy.

#### Calculating Family Payments

Our Annual Tuition Fees featured above represents the Year Level Fees that will apply to students attending Sunrise Christian School Marion in Reception to Year 10 before any discounts or fee reductions have been applied.

*Sunrise Middle School Yr 7-10 will be run in partnership with Temple Christian College, however Fees will be charged by Sunrise Christian School through FACTS.*

#### Multiple Sibling Discounts - NEW

*Across Sister Schools - Sunrise and Temple*

Multiple Sibling Discount is applicable to Sunrise Christian School families who have more than one student enrolled at Sunrise Christian School. This also applies to families that have more than one student enrolled at Sunrise Christian School and Temple Christian College. *The discount applies to the total annual tuition fees for each student across both schools.*

Families with 2 students	20%
Families with 3 students	30%
Families with 4 Students	40%
5th and subsequent students	Free

#### Tuition Fee Concessions/ Fee Reductions

Our passion at Sunrise Christian School is to provide a quality and affordable experience for every student seeking an authentic Christian Education. Fee concessions are available to families who consider that they can not meet the payment of full fees.

**When assessing for fee reductions, eligibility is generally based on household income, however, other factors such as number of children are also considered. There is no income limit as such, but as a guide, a household income of up to \$80,000 would be considered for a single student. If your income is around this amount or higher and you have more than one child at Sunrise, then we encourage you to apply as you too may be eligible.**

For families previously approved for a School Card or solely dependent on Centrelink Benefits where the combined household income is under \$40,000, fees will be charged at the rate shown in the above table once proof of income is provided.

#### Please note:

*A new application for fee reduction assistance is required each new school year.*

#### Annual Fee Payment Discount

Payment paid in full

A settlement discount of 5% applies if the Annual Tuition Fees are paid within the first two weeks of Term 1 2019 providing there are no outstanding fees from the previous year.

#### Building Fund Donation

**All Building Fund donations are tax deductible.**

\$320 per annum per family (\$80 per term).

To help us maintain and develop school facilities for our students, each family is requested to contribute to the School's Building Fund on a voluntary basis. You are welcome to nominate an alternative amount.

Any additional donations are gratefully received.

#### Example of how to calculate fees:

*Family with 3 children at Sunrise - 30% discount applied to each child.*

Child 1 Yr 7 - \$ 5,550 less 30%	= \$ 3,885
Child 2 Yr 4 - \$ 5,010 less 30%	= \$ 3,507
Child 3 Rec - \$ 4,800 less 30%	= \$ 3,360
<b>Total Fees</b>	<b>= \$ 10,752</b>

*Families with 2 children at Sunrise and 2 children at Temple - 40% discount applied to each child.*

Sunrise Fees will be:

Child 1 Yr 6 - \$ 5,150 less 40%	= \$ 3,090
Child 2 Yr 4 - \$ 5,010 less 40%	= \$ 3,006
<b>Total Fees</b>	<b>= \$ 6,096</b>

*Temple Christian College fees will receive the same % discount.*

**When a student intends to leave the School a full school terms notice must be provided to the Principal in writing.**

**Failure to give notice will incur one terms school fees in lieu of notice.**
